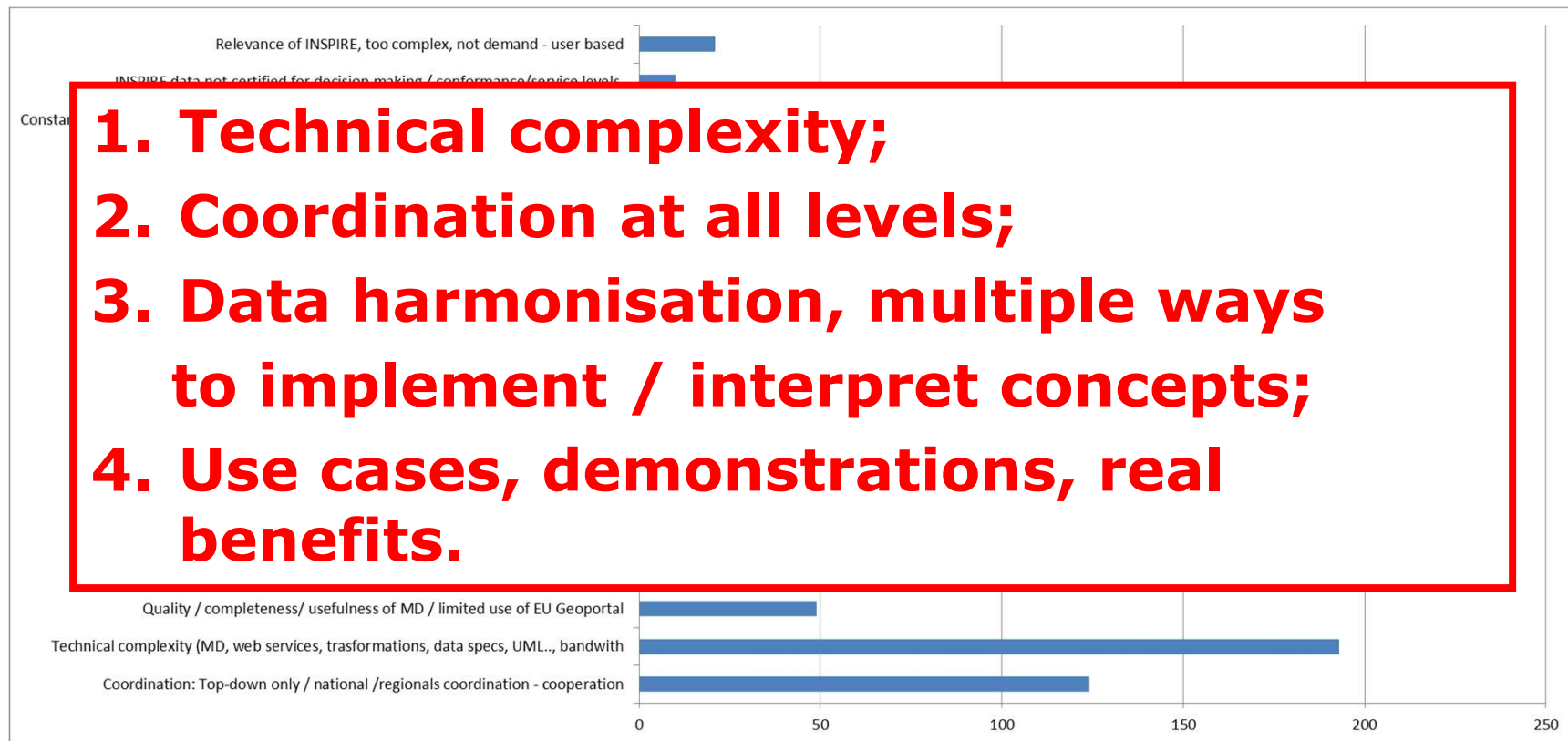

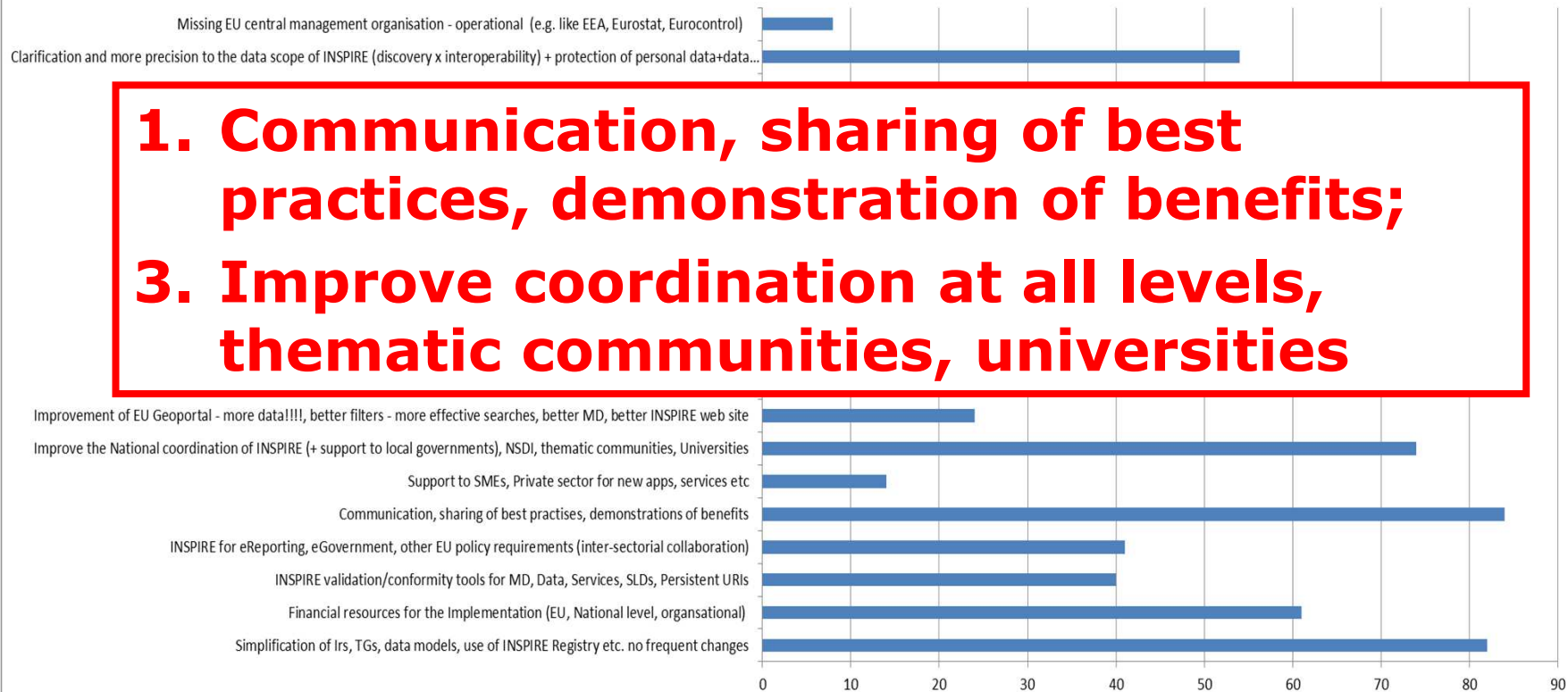

INSPIRE mid-term evaluation public survey (changes proposed)

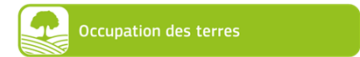
Statistics of the responses about changes proposed



- 1. Communication, sharing of best practices, demonstration of benefits;**

- 3. Improve coordination at all levels, thematic communities, universities**

Implementation of INSPIRE in thematic domains

- Many INSPIRE implementation issues are **theme-specific**:
 - data scope,
 - extending data models for domain purposes / applications,
 - temporal / spatial resolutions; levels of detail / scales,
 - used parameters,
 - used terminology (open and empty code lists),
 - software and TG options (e.g. download service) used.
- No agreed way for implementers in MS to **share their experience**
- No coherent **overview of the status** of the implementation for the different INSPIRE data themes.





Exchange of implementation experiences in thematic domains

Proposed action:

- **Build communities of INSPIRE implementers** in the EU as well as in MSs around **clusters of themes**
- Create an **on-line platform** (e.g. a re-designed INSPIRE forum) for sharing experiences and for discussing implementation issues and approaches.
- **Address** already identified issues on data specifications of Annex I, II and III and **propose** (if relevant) concrete change proposals to the INSPIRE MIG

Exchange of implementation experiences in thematic domains

Objectives:

- **Support successful implementation** (e.g. developed applications) of INSPIRE by MSs or thematic communities in order to **demonstrate its benefits**.
- **To seek/agree on common “harmonised” implementation solutions**, i.e. what tools or which options in the TG to use (where there are several) what extensions or value-added applications to develop or plan.

The idea is not new!!

INSPIRE Forum:

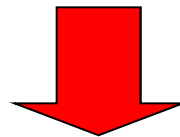
" Connecting people and sharing knowledge "

- an open space for the exchange of information, best practice, news, opinions on issues relating to INSPIRE;
- a meeting place to get to know professionals working in different countries and thematic areas;
- a learning space where you can download tutorials, workshops, presentations and learn about and participate in upcoming workshops and conferences

Why the effort then!!

- The INSPIRE Forum **activity** has been recently **very low**;
- **new more formal tasks** related to the implementation of INSPIRE.



More **concentrated effort is needed to support** MSs / stakeholders etc. with implementing INSPIRE – **single point of contact for theme specific** implementing issues.



Call for the **INSPIRE** Thematic clusters facilitators

- The Call for Facilitators published on 13.8 and closed on 19.9.

Main criteria for selection:

- General knowledge of INSPIRE
- **Good international/national community building experience (supporting networks)**
- Participation in development of INSPIRE legal/technical framework
- Participation in the national implementation of INSPIRE
- Participation in EU, National SDI projects
- Collaborative SW tools experience

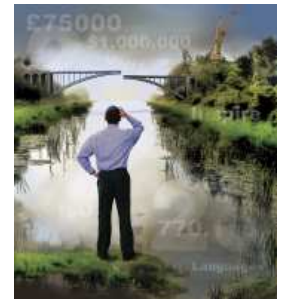

Foreseen tasks for the cluster facilitators (Phase 1 -2)

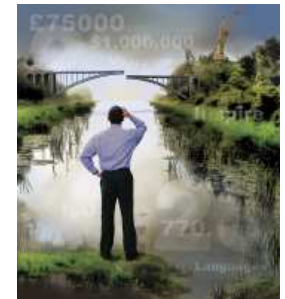
- Facilitate communication / **exchange of implementation** progress, common decisions, priorities, roadmaps
- Identify and **maintain network of thematic experts** (knowledge base)
- Identify and **share results** of relevant EU/national projects, initiatives and operational implementations (SW tools, methodology, Use cases etc.)



Tasks for cluster facilitators – Phase 1

Task 1: State of the implementation in a thematic domain / cluster

- aggregation of the thematic stakeholders;
- identification of key implementation issues, constraints, challenges for each INSPIRE data theme covered by the thematic cluster;
- identification and aggregation of completed and current projects related to the INSPIRE thematic cluster;
- identification and aggregation of successful implementation (applications, services etc.) of INSPIRE in the thematic domain;
- identification of re-usable SW tools used for implementing INSPIRE in the thematic domain.

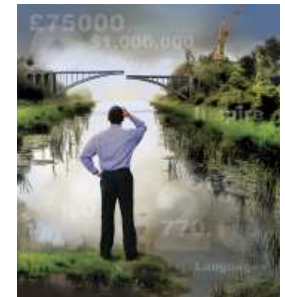


Tasks for cluster facilitators – Phase 1

Task 2.1: Content maintenance and promotion of the on-line platform

Acting as the administrator of the on-line platform, set up and provided by the JRC, e.g.:

- facilitating and chairing the discussion of thematic implementation issues, approaches and requirements in each MS and of possible common approaches for INSPIRE implementation;
- structuring the forum according to thematic needs and assign the sub sections facilitators (if relevant);
- monitoring the use of the forum and inform the JRC when a particular action may be necessary.

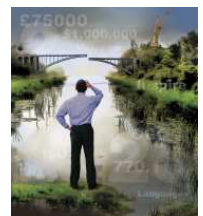


Tasks for cluster facilitators – Phase 1

Task 2.2: Content maintenance and promotion of the on-line platform

Promoting the use of the platform inside (but not only) the thematic cluster community by e.g.:

- encouraging thematic experts and users from as many countries as possible to share details of relevant software products / tools being used, which options in the TG they use or what extensions and value-added applications are being developed or planned;
- publishing results from EU / national projects, usability tests, etc.;
- answering thematic questions and publishing the answers on the forum;
- facilitating the exchange of relevant theme-specific activities in the MS (pilot applications, project proposals, cross border collaboration, SW development etc..).



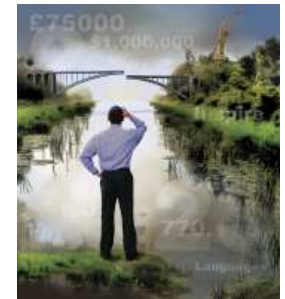
Tasks for cluster facilitators – Phase 2

Task 3: Content maintenance and promotion of the on-line platform

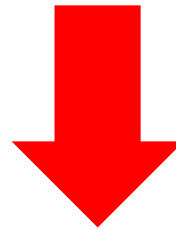
- Continuation of activity related to the administration of the platform, the facilitation of discussions as well as the promotion of the platform in the relevant thematic communities.

Task 4: Maintenance of the INSPIRE Technical Guidelines

- Reviewing, of the current version of the related INSPIRE Data specifications – Technical Guidelines (TG);
- facilitating and consolidating the discussion on change proposals for the INSPIRE data;
- specifications for relevant themes and, where necessary, other INSPIRE Technical Guidelines;
- submitting concrete change proposals, based on implementation experience, of the Technical Guidelines to the INSPIRE MIG for further discussion and endorsement.

Summary from the Kick –off meeting in Ispra 13-14.10.

- Need for cross domain/cluster coordination;
 - Working across and between clusters
- Need for common structure of the 9 collaboration platforms;
- Alignment of the external communication;
 - Building communities beyond existing communities
- Tasks for the first 2 months;
 - **24.11. launch of the thematic platforms**
- Initial resources to be used;
 - Experts to be involved
 - Content to be evaluated
- Do not duplicate already existing activities;



In summary

Engaging INSPIRE thematic communities is to:

1. To keep up the “momentum” – participatory, open process from the development of the IRs, TGs also for the INSPIRE implementation phase
2. To mobilize thematic communities to share best practices about implementing / utilizing INSPIRE in their domains.
